### Memorandum of Understanding

This Memorandum of Understanding made of this 1<sup>st</sup> Day of the month of October of the year 2022

BETWEEN

**Faculty of Architecture and Planning, (FoAP), Dr. A.P.J. Abdul Kalam Technical University, Lucknow** with head office located at Tagore Marg, Lucknow – 226007, hereinafter referred to as the FIRST PARTY, which expression shall mean and include its representatives, successors, and assigns,

AND

**Prayagraj Municipal Corporation (PMC), Prayagraj** with head office located at 1, Sarojini Naidu Marg, Civil Lines, Prayagraj – 211001, hereinafter referred to as the SECOND PARTY, which expression shall mean and include its representatives, successors, and assigns

HEREBY WITNESSEETH AS FOLLOWS:

WHEREAS the FoAP, Lucknow (Earlier Government College of Architecture) was established in 1911 as College of Arts and Crafts that was re-established in 1980 as a Government College of Architecture. Today, it is the Faculty of Architecture Dr. A.P.J. Abdul Kalam Technical University. Besides the under-graduate program, the institute runs 4 post-graduate programs as well. There is a PhD program that has over 40 research scholars. The Architecture department is committed to produce best equipped architects and planners, to take up the challenges of physical and socio- environmental development of the global standards. The Institute strives for social sustenance through universal design, cultural sustenance through conservation and environmental sustenance through the disciplines of architecture, planning and design. The FOA, AKTU is already involved in Institutional Consultancy of Architecture, Planning, Landscape, Conservation, and Interior Design and


therefore partners in prestigious design and Development projects of Central and State Government.

WHEREAS the PMC, Prayagraj is the Municipal Corporation responsible for the civic infrastructure and administration of the city of Prayagraj. It was established in 1863 as the Municipal Board of Allahabad under the act of 26 of 1850. The board was changed to corporation in 1959. It administers an area of 365 km<sup>2</sup>.

WHEREAS representatives of both the above organizations met and discussed areas of mutual interest and benefit and expressed a desire to exchange and collaborate for the benefit of Urban Planning and Architecture sector at large, in tune with the policies of the Government of India and Government of Uttar Pradesh,

THEREFORE, NOEW HEREBY, THIS MEMOREANDUM OF UNDERSTANDING  
WITNESSEETH AS FOLLOWS:

- THAT FoAP, Lucknow and PMC, Prayagraj shall exchange and share knowledge, papers and reports, wherever feasible, on various aspects of design, execution and maintenance related to buildings,
- THAT FoAP, Lucknow and PMC Prayagraj shall design and conduct, wherever feasible, various academic, research, training, and capacity building programmes of varying duration,
- THAT FoAP, Lucknow and PMC, Prayagraj shall jointly work, wherever feasible, on design, research, and consultancy projects.
- THAT PMC, Prayagraj may engage the consultancy services of FoAP, Lucknow for design of buildings, layouts/ GIS Mapping of areas, as the case may be, as per requirements,
- THAT this MoU does not envisage any financial commitment from either of the parties who are signatory to this Memorandum and if there are any financial





commitments, they shall be deliberated, decided upon and agreed to, as and when the need arises, through separate agreements, as and when required,

- THAT in case one party engages the other party for any consultancy work on any nature related to design, execution and maintenance of public works, consultancy fees, if any, shall be decided upon, on a case-to-case basis, as the situation demands,
- THAT both parties may undertake any such activity which is of mutual interest to the parties concerned and in tune with the policies of the Government of India and Government of Uttar Pradesh in the interest of the design, execution, and maintenance of public works,
- THAT, this MoU is entirely voluntary in nature from both parties, shall be valid for a period of three years from the date of signing and can be modified and/or extended, on mutual consent, by giving a notice of three months on either side and terminated by either party, without according any reason, by giving a notice of three months on either side.

IN AGREEMENT AND WITNESS THEREOF, both the above-mentioned parties hereby affix their signature and seal.
